Coverage of any service is determined by a member's eligibility, benefit limits for the service or services rendered and the application of the Plan's Medical Policy. Final payment is subject to the application of claims adjudication edits common to the industry and the **Plan's professional or facility services claims coding policies**. Reimbursement is restricted to the provider's scope of practice as well as the fee schedule applicable to that provider.

<b>Purpose</b>	To define the Plan's limitations for consultation code services that are submitted on a CMS-1500 paper claim form or an 837P electronic claim form.
<b>Scope</b>	Applies to all Premera Blue Cross, Premera Blue Cross Blue Shield of Alaska, LifeWise Health Plan of Washington, LifeWise Assurance Company and Premera Blue Cross HMO lines of business and products.
<b>Policy</b>	<p>Consultation codes, both inpatient and outpatient, are eligible for reimbursement only when billed by providers contracted on a 2009 or earlier Resource Based Relative Value System (RBRVS) fee agreement. Consultation codes submitted by all other providers are not eligible for reimbursement.</p> <p>Consultation services previously reported with one of the consultation codes must be reported with an appropriate Evaluation and Management (E&amp;M) procedure code, such as but not limited to, an office visit code, hospital care code, nursing facility care code or a home visit code in order to be considered for reimbursement.</p> <p>If any allowed amount indicated above exceeds the billed charge for the claim line, that line will allow at the billed charge.</p>
<b>Codes/Coding Guidelines</b>	<p>For the purpose of this policy, the consultation codes that are not separately reimbursable include the following:</p> <p><b><u>Inpatient and Outpatient Consultations:</u></b></p> <p><b><u>Outpatient:</u></b></p> <ul style="list-style-type: none"> <li>• <b>99242</b> - Office or other outpatient consultation for a new or established patient, which requires a medically appropriate history and/or examination and straightforward medical decision making. When using total time on the date of the encounter for code selection, 20 minutes must be met or exceeded.</li> <li>• <b>99243</b> - Office or other outpatient consultation for a new or established patient, which requires a medically appropriate history and/or examination and low level of medical decision making. When using total time on the date of the encounter for code selection, 30 minutes must be met or exceeded.</li> <li>• <b>99244</b> - Office or other outpatient consultation for a new or established patient, which requires a medically appropriate history and/or examination and moderate level of medical decision making. When using total time on the date of the encounter for code selection, 40 minutes must be met or exceeded.</li> <li>• <b>99245</b> - Office or other outpatient consultation for a new or established patient, which requires a medically appropriate history and/or examination and high</li> </ul>

When using total time on the date of the encounter for code selection, 55 minutes must be met or exceeded.</p> <p><b><u>Inpatient:</u></b></p> <ul style="list-style-type: none"> <li>• <b>99252</b> - Inpatient or observation consultation for a new or established patient, which requires a medically appropriate history and/or examination and straightforward medical decision making. When using total time on the date of the encounter for code selection, 35 minutes must be met or exceeded.</li> <li>• <b>99253</b> - Inpatient or observation consultation for a new or established patient, which requires a medically appropriate history and/or examination and low level of medical decision making. When using total time on the date of the encounter for code selection, 45 minutes must be met or exceeded.</li> <li>• <b>99254</b> - Inpatient or observation consultation for a new or established patient, which requires a medically appropriate history and/or examination and moderate level of medical decision making. When using total time on the date of the encounter for code selection, 60 minutes must be met or exceeded.</li> <li>• <b>99255</b> - Inpatient or observation consultation for a new or established patient, which requires a medically appropriate history and/or examination and high level of medical decision making. When using total time on the date of the encounter for code selection, 80 minutes must be met or exceeded.</li> </ul>
<b>Violations of Policy</b>	<p>Violations of this policy by any party that enters into a written arrangement with the Plan may result in increased auditing and monitoring, performance guarantee contractual penalties and/or termination of the contract. Disciplinary actions will be determined in Plan's sole discretion.</p> <p>Violations of this policy may be grounds for corrective action, up to and including termination of employment.</p>
<b>Exceptions</b>	<p>For contracted Alaska providers: Consultation charges for dates of service prior to December 11, 2023, will be eligible for reimbursement. Consultation charges for dates of service on or after December 11, 2023, will be subject to the policy criteria.</p> <p>All other providers are subject to the policy criteria.</p>
